Membership in the 116th Pennsylvania Volunteer Infantry may be denied if you: a) make any untrue or incomplete statements on this form; b) have past or present violations of laws or ordinances (including a violation that did not lead to a conviction) which present a reasonable doubt as to your ability to perform as a member without endangering property or the public health or safety; or, c) have pending arrests (including outstanding warrants) for violations of the law which present a reasonable doubt as to your ability to perform responsibilities without endangering the welfare of the community.

Membership shall not be denied on the basis of sex, marital status, religion, race, ethnic origin, physical abilities, or sexual orientation. Membership may be denied for any other reason.

Below list all family members. **Please indicate birth dates for all minors to determine voting rights.** If no birthday is listed it will be assumed the person is under sixteen (16) years of age and will have no voting rights.

GENERAL RELEASE OF LIABILITY

I am fully aware of the nature and purpose of the activities of the 116th Pennsylvania Volunteer Infantry, Company B (116 PVI)/4th California Volunteer Infantry, Company D (4th CVI). I agree to be bound by the bylaws, rules, and policies of the 116th PVI/4th CVI and to obey the direction of the governing officials at 116th PVI/4th CVI -sanctioned events. I acknowledge that reenacting, black powder shooting, and related activities are hazardous, and that I have made a voluntary choice to participate. I agree to assume any and all risks of injury or death that may result from my participation in 116th PVI/4th CVI events. I agree to release, waive, and discharge from all liability to myself or to any of my family members, and promise not to sue, the 116th PVI/4th CVI, its governing officials, its board of directors, or the owner or lessor of any property on which the 116th PVI/4th CVI conducts activity, whether caused by those parties' negligence or any other reason, for any injuries which may result from preparing for, practicing for, traveling to or from, or participating in any 116th PVI/4th CVI - sanctioned events. I agree to indemnify and hold harmless the parties released above and each of them from any loss, liability, damage, or claim they may incur due to my actions during 116th PVI/4th CVI events, whether caused by their negligence or otherwise. I understand that the 116th PVI/4th CVI will not provide compensation for any injury to me, nor for any damage to my property while participating in any/all 116th PVI/4th CVI sanctioned events. I must pay for any such injury or damage to property or myself through my own insurance, since the 116th PVI/4th CVI does not provide insurance coverage to cover my losses or injuries. Accordingly, if I injure someone or cause property damage to someone's property while participating at any/all 116th PVI/4th CVI sanctioned events, the fact that the 116th PVI/4th CVI does not provide insurance coverage, does not prevent the injured party from seeking compensation from me. It is my intent that this release be as broad and inclusive as allowed by law, and that if any portion is invalid the remainder shall continue in full force and effect. This release is entered into solely for 116th PVI/4th CVI - sanctioned events and does not confer a release upon any parties for their actions when not acting in furtherance thereof. I have read, understood, and freely agree to this release and all its terms.
